Job Title: Climate Smart Farming Program Specialist

The Community Alliance with Family Farmers (CAFF) is an exciting and dynamic non-profit organization whose mission is to build sustainable food and farming systems through policy advocacy and on-the-ground programs that create more resilient family farms, communities and ecosystems. CAFF is based in Davis, with satellite offices statewide. Working remotely some of the time is a possibility. CAFF is a membership organization guided by a board of directors that includes family farmers and others who are passionate about food, farming and the environment. CAFF provides technical assistance to farmers to access new markets, provides on-the-ground technical assistance to farmers on water, food safety, and climate smart practices, and maintains a policy program in Sacramento. POSITION SUMMARY

The Climate Smart Farming (CSF) Program Specialist’s primary role is to oversee the development and implementation of CAFF’s on–the-ground components of the CSF program. The CSF Program Specialist will work with farms, researchers, and other agencies in running pilot projects to test farming practices that sequester carbon and improve soil health. CAFF will use the results of the pilot projects to design a program that reaches family farmers in regions throughout California. The CSF Program Specialist will work with the Policy Director and CalCAN staff to garner state support for climate smart practices; with Cooperative Extension, the RCDs, commodity organizations, and other partners conducting outreach to farmers on climate smart farming; with university researchers on demonstrating the carbon sequestration potential of particular practices. CAFF’s role is to encourage the adoption of climate smart practices on family farms in California.
